ELECTION OF OFFICERS & DIRECTORS

- Pelada FA's Board of Directors must have between 5 and 15 members (currently 8).
- All members of the Board will be elected at the AGM.
- The term length for Board positions will be **two years** unless otherwise specified.
- Each **officer** is limited to **three consecutive terms** in the same office.
- **President, Treasurer**, & ½ of Directors at Large are elected in even numbered years.
- Vice President, Secretary, & ½ of Directors at Large are elected in odd numbered years.



- Coaches, volunteers, board members, and members of staff who are registered with OYSA are also entitled to vote, even if they do not have a player in the the Academy.

ELECTRONIC VOTING PROCESS

- An electronic ballot and summary of actions open to voting will be sent to attendees in advance of the AGM.
- The Meeting Chair will **open discussion** of proposed ballot actions. This is your opportunity to comment, ask questions, address issues, or voice any objections you may have.
- Members of the board will move and second the motion to vote. This is your opportunity to submit your electronic ballot or a revised ballot if you voted prior to the meeting.
- Members will have 30 minutes from opening of voting to submit or revise ballots.
- After voting has closed, ballots will be tabulated and results will be announced at the end of the meeting. The total number of ballots returned will constitute a quorum and a simple majority of the votes cast will be required to approve each action.




2022-23 REVENUES




- Revenue is "Cash" basis

 - Received \$6k in donations/support


2022-23 FINANCIAL AID



ENROLLMENT By Season






- Public Support Employee Retention Credit: >\$70k submitted in March, waiting federal payout

- 20-21 benefited from timing of payments and Federal Support
- 21-22 and 22-23 lost money (cash basis) as no federal support and increased wages
- 23-24 increased wages but planning 71k federal Employee Retention Credit payment

KEY AREAS OF INCREASED COST

Rising costs have forced player fee increases the past two years. The most significant contributing factors are:

- **Field rental costs** at our primary facilities have increased by 25-30% compared to pre-pandemic rates.
- **Tournament and cup registration costs** have more than doubled due to a combination of rising fees and increased participation in postseason cups.
- Coach certifications, training, and cost of living wage increases.
- Addition of services such as Veo cameras.
- Financial Aid needs have doubled relative to pre-pandemic years.

DEFINING "PELADA"

The word **Pelada** [pronounced Pay-lah-dah] comes from Brazil and describes an informal game of soccer between friends. Peladas are played everywhere, everyday, motivated by nothing more than love for the game and the sense of community at its core.



FOUR PILLARS OF THE PELADA ACADEMY MODEL

Coaches as Educators:

Certified coaches who participate in ongoing education and understand their roles as teachers, role models, and life mentors for children.

Positive Approach and Human Development:

Inclusive and supportive environments for players; insistence on fair play. Train leaders and foster mentoring relationships between players.

Flexibility and Opportunities for All:

No tryouts. Every player is welcome and plays at least 50% of each match. Registration is seasonal, year-round participation is optional (multi-sport athletes welcome!)

Competitive Player Development:

Curriculum and club practices designed to improve each player's standard of play and ability to compete at a high level.

RECORD PLAYER PARTICIPATION: 2022-23 set all time highs for participation for a second year in a row.

- **576 players** participated in 2022-23 (**461** players in 2021-22)
- **1330 program registrations** in 2022-23 (**1150** registrations in 2021-22)





ADD 6-WEEK PROGRAMS TO THE CALENDAR AT THE END OF THE FALL & SPRING SEASONS

GROW PARTICIPATION ENOUGH TO ALLOW INTERNAL **LEAGUE PLAY**OPTIONS FOR U7-U8 PLAYERS

The **COACH DEVELOPMENT ACADEMY** is a leadership and mentoring program for players U11 and older (2013–2005 birth years)

- **42 YOUTH COACHES** enrolled in 2023-24.
- Averaging 25 youth coaches at each Foundations Academy event this summer, allowing us to boast a 1-to-1 coach-to-player ratio and a super kid-friendly environment!
- No participation fee to be eligible, players must be rostered on our fall, winter, or spring outdoor teams).
 - Youth coaches are eligible to join the paid staff after turning 16.
